Hello Mr. Šinágl

I forgot to add in my last letter to you, That there should be a Recorded Communication between the U.S. Embassy and the State Department regarding the monthly visitation issue. It's quite apparent the former consul David Beam intentionally falsely communicated to the state Dept i WAS RECEIVING monthly visitation here in Valdice when i WAS NOT AND i WANT TO ALSO ADD THAT i NEVER RECEIVED MONTHLY VISITATION BY THE EMBASSY DURING pretrial either when i WAS CONTINUALY REMANDED IN PANKRAČ PRISON BY JUDGE JAN KADLEC FOR HAVING LANGUAGE ABILITIES AND NO EVIDENCE AGAINST ME WHATSOEVER! Mr Šinágl if you would, please forward A copy of this letter to Mr. TAKAUBEK so he can forward it to Ms. TURNER AT SENATOR BROWNS OFFICE AND ASK HER TO REQUEST A COPY OF THE COMMUNICATION BETWEEN THE EMBASSY AND THE STATE DEPT IN REGARDS TO THE ABOVE. IT'S CLEAR TO ME THE EMBASSY STAFF HERE IS INTENTIONALLY CONCEALING THIS AND AS IT APPEARS TO ME MS. JOYCE W. NAMDE OF THE STATE DEPT! AND LASTLY ITS ALSO VERY APPARENT SIR BOTH THE BRITISH AND U.S. EMBASSYS AS WELL AS MS. NAMDE KNOW AND HAVE KNOWN MY HUMAN RIGHTS, MY HUMAN DIGNITY AND LEGAL RIGHTS HAVE BEEN VIOLATED AND THEY AND THE CZECH MINISTRY OF FOREIGN AFFAIRS ARE TRYING TO SWEEP IT ALL UNDER THE RUG AND THERE'S NO DOUBT IN MY MIND THEY KNOW AND HAVE KNOWN SO-CALLED INVESTIGATION INTO MY MISTREATMENT WAS FAKE WHICH MEANS THEY CONDONEING, ACCEPTING AND IN MY VIEW PARTICIPATING IN COVERING UP A HIGHLY CRIMINAL INTERNATIONAL INCIDENT AND MAJOR FELONY CRIMES PERPETRATED AGAINST AN AMERICAN AND BRITISH CITIZEN! I KNOW I HAVE REPEATED MYSELF SIR BUT PLEASE EXCUSE IT AS HERE IT IS ALMOST 2 YEARS AND SEVERAL MONTHS OF INVESTIGATION BY THE STATE DEPT AND I STILL HAVE NO ANSWERS TO MANY QUESTIONS. WHICH IN ITSELF TELLS THE WHOLE STORY!
